Every municipality and government agency in the State of Illinois is authorized to participate in this program.

The bid for this vehicle was published in the legal Section of both the Daily Herald and the Southtown Star on 1-28-09. The bid was awarded through a sealed bid process to Sutton Ford for the 2010 model year.

The attached summary sheets highlight most standard equipment and lists other vehicle options (including a hybrid package). Additional option pricing for items not shown is available by contacting the Fleet Manager, Lou Zager directly at 708-720-8035.

It is anticipated that pricing for this vehicle secured by the Suburban Purchasing Cooperative, will be held firm through the 2010 model year. Municipalities need to order their vehicles during the months of February through Mid-June in order to receive their vehicles in a timely fashion and avoid production delays. The anticipated cut-off date to order this Ford is May 14, 2010. Delivery to be made within 90 calendar days after production of said vehicle.
