This letter is to inform you that the Governing Board of the Suburban Purchasing Cooperative has approved the award of the SPC 2018 Type 3 Medium Duty Ambulance Contract #177 to Fire Service Inc. for Wheeled Coach and Foster Coach Sales Inc. for Horton Emergency Vehicles. Both firms submitted responsive, responsible bids and the award is based on the SPC Fire Core Cost Containment Committee's analysis of all proposals.
