The Suburban Purchasing Cooperative’s Governing Board has approved the award of the SPC 2011 Thermoplastic Lane Marking contract to Superior Road Striping, Melrose Park, IL. The contract is in conjunction with the Illinois Department of Transportation and has been awarded to Superior Road Striping based on their response as the lowest bidder being in compliance with all bid specification requirements. Superior Road Striping has agreed to all terms and conditions set forth in the specifications contained within the attached Request for Proposals to which they responded. The duration of the contract is May 6, 2011 to September 30, 2011.

The winning bid (Attachment A) is included for your files, along with a copy of the signed award letter (Attachment B) and signed copy of IDOT BLR 12320 Contract (Attachment C).

You municipality will need to comply with the requirements set forth by IDOT, as outlined in the April 26 memo, which is attached for your convenience (Attachments D). IDOT will not allow work to be in your municipality until they receive the original signed, sealed BLR 14230 Resolution for Maintenance of Streets and Highways and 4 sets of original BLR 14231 Municipal Estimate of Maintenance Costs that includes an engineering line item for the SPC Preliminary Engineering Fee of 4%.
