North Shore policies dictate that projects receive a 3% cost increase annual to account for inflation. The 3% cost increase amounts to an additional \$409,333 in federal STP funding for programmed phases.

The North Shore Council has received approval for \$96,598 in advanced funding for projects in FFY 2011. Currently, the Council of Mayors is working with IDOT, CMAP and FHWA to consider revisions to the functional classification process.

VIII. Clean Construction or Demolition Debris (CCDD)

Recently signed legislation (PA 96-1416) has made changes to Clean Construction or Demolition Debris (CCDD) requirements. The Illinois Environmental Protection Agency (IEPA) website provides information about the changes here: <http://www.epa.state.il.us/land/ccdd/index.html>. Especially relevant to municipalities is the interim provision requiring that fill operators obtain for all soil:

- a. Certification from the owner or operator of the site of origin that the site has never been used for commercial or industrial purposes and is presumed to be uncontaminated soil; or
- b. Certification from a licensed professional engineer that the soil is uncontaminated.

IEPA has stated that soil within a public roadway right-of-way is considered industrial/commercial because it does not meet the definition of residential property, conservation property or agricultural property. IEPA has held multiple seminars to explain the requirements of the legislation. Staff will discuss the implications for municipalities and potential NWMC actions.

I. Call to Order

II. Approval of Meeting Minutes – March 17, 2010

Chair Mayerhofer asked for a motion to approve the meeting minutes from January 27, 2010. *On a motion from Mr. Kendzior, seconded by Mr. Schneider, the minutes passed unanimously.*

III. Resources for Green Infrastructure

Mr. Newport reported that he was invited to present at today's meeting to introduce and discuss resources for green infrastructure. He explained that the Environmental Protection Agency's (EPA) main interest in green infrastructure comes through stormwater runoff and the pollution it can cause for rivers and waterways. He said that the State Revolving Fund is one source for green infrastructure projects. He mentioned that the American Recovery and

Reinvestment Act (ARRA) included a twenty percent set aside for green projects related to the State Revolving Fund. He provided information on a nonpoint source grant program and a soon to be released green grants program. He said that information about the green grants program will be released in the coming months. He distributed a handout with a list of technical resources and journal articles. Finally, he distributed a green streets guide.

Mr. Jensen asked if EPA or anyone is working on materials testing and providing standards. Mr. Newport responded that pervious pavers and concrete do require a different maintenance regime; however, he noted that there are not yet nationally accepted design and maintenance standards. He said that sample specs are available. Mr. Tomich asked about the number of contractors that are certified to pour permeable concrete. Mr. Newport responded that there are a limited number of certified contractors and he noted that he could provide a list to the group. He said the limited number of contractors can have upward pressure on prices. Mr. Cruz said that Wilmette looked at doing a green alleys program and received resistance from MWRD due to concerns about infiltration in the combined sewer area. Mr. Newport said that EPA has been discussing MWRD's accepted practices and he noted that they are very cautious of green infrastructure solutions.

IV. Agency Reports

A. IDOT Highway Report

Mr. Stallworth reported that Earl Dunn could not attend today's meeting, but Mr. Stallworth did bring the regular status sheet. Mr. Staron said that any questions could be directed to Earl Dunn. Mr. Jensen asked how others deal with public input when IDOT has a project near a school. Mr. Schattner said all you can do is stay involved in the process and attend the meetings. Mr. Kendzior acknowledged the difficulty in timing projects efficiently and accommodating local concerns. He said that sometimes with smaller projects the Bureau of Construction will shift the schedule to accommodate the end of the school year or some other event. Mr. Jensen said that he recognizes that the state needs to complete projects and noted that even good communication will leave some people upset.

B. Cook County Highway Department

Mr. Bettenhaus distributed a status sheet of CCHD projects in the North Shore area. He said that Cook County is finalizing its MYP for 2011-2014. He said that the county is facing financial constraints like other local governments and that the program will reflect those constraints. For instance, he said that the Crawford Ave. project is being deferred due to funding availability. He noted that the Winnetka Rd. bridge project using ARRA funding from the North Shore Council is currently under construction.

C. Pace

Ms. Donner reported that the construction affects the performance of bus routes. She informed the committee that she will inform municipalities of detours on any routes due to construction. She said that Pace is examining Route 208 and considering changes. She said one of the changes being considered is to discontinue the stop at the Old Orchard Courthouse.

D. Illinois Tollway

Ms. Anderson reported that construction on the Edens Spur will begin in two weeks and be completed by the end of 2010. She also provided information on the Tollway Help Trucks, which assisted approximately 35,000 motorists in 2009. She said that motorists can call *999 to reach Help Trucks. She said that a free child seat inspection will take place at the Lake Forest Oasis. She noted that Kristi Lafeur is the new Executive Director for the Tollway and is working with a Tollway transition team to help chart the future of the Illinois Tollway. Mr. Kendzior asked if there was a reason that construction on the Edens Spur was beginning right before the July 4 weekend. Ms. Anderson responded that she could find out more information about the construction schedule. Mr. Schattner asked if the Tollway has been installing more sound walls. Ms. Anderson responded that the Tollway has a policy for the installation of sound barriers. She explained that noise studies are undertaken whenever a roadway is widened. She noted that the construction on the Edens Spur includes sound walls.

E. Chicago Metropolitan Agency for Planning (CMAP)

Ms. Schaad reported that the draft Go To 2040 Plan, which is the regional comprehensive plan, is now available for review and comment. She said that the Council of Mayors Executive Committee is meeting at the end of the month to discuss the funding marks. She informed the committee that four North Shore municipalities have not returned the CMAP municipal survey, which will be used to complete the regional indicators database. She reported that CMAP requested updates on CMAQ projects and noted that a few project sponsors still need to submit information. She distributed the STP expenditure reported and said that the suburbs are on track to overspend their federal allotment again. She distributed the ARRA expenditure report. Mr. Schattner asked if CMAP could enable a print function for the CMAQ updates. He noted that it is nice to have a record of the submitted information.

F. IDOT Local Roads

Mr. Stallworth reported that the Chestnut Ave. at Waukegan Rd. design approval has been moved back to October 2010, the Gross Point Rd. design approval has been pushed back to December 2010, and the Willow Rd. project in Winnetka has been pushed back to December 2010. He informed the committee that two more ARRA funded projects have been awarded in Morton Grove and Evanston.

He reported that the Bureau of Local Roads at District One has been reorganized. He explained that Alex and he will only be covering Phase I for most projects. He said that Chris Holt will be the main contact for Phase II, but consultants will handle the processing.

V. North Shore Council of Mayors FFY 2010-2014 Surface Transportation Program

A. Current North Shore STP FFY 2010-2014

Mr. Staron reported that the current program has not changed since last meeting. He noted that 2011 and 2012 are full years and the North Shore Council is headed towards a negative \$14 million balance.

B. STP Programming Strategies

Mr. Schattner reported that a meeting was held on June 3 to discuss programming strategies for the North Shore Council. He noted that the attachment summarizes the conversation and issues. He said the meeting discussed cost increases, relationships with IDOT and programming strategies for the future. He said that one thing not discussed in the memo was the desire to include more resurfacing projects like the ARRA program. Mr. Staron reported that the June 3 meeting was called after he received over \$4.5 million in program requests. He said that the current spending of the North Shore Council is unsustainable. He referenced the changing regional landscape and noted that the region no longer is sitting on a large unobligated balance. He informed the committee that the outcome of the meeting was essentially that there will be no cost increases and municipalities need to work with IDOT and NWMC staff to understand and address significant cost increases. He reported that staff will work with project sponsors to shift projects into 2013-2014 and provide more balance to the program and prevent a large negative balance. He explained that the earliest that new projects could come into the program would be FFY 2015. Mr. Tomich asked how scope creep will be addressed. Mr. Staron responded that it is a difficult issue for municipalities to document. He said that he thinks it is appropriate to attempt to address any concerns at the project level with the field engineers before moving up the IDOT ladder. He noted that it can be difficult to bring these issues to IDOT. Mr. Jensen said that part of the problem with cost increases is the fact that the projects starts with a very initial cost estimate; however, he said that IDOT should play a larger financial role in projects where it is requiring additional scope. Mr. Schattner asked if IDOT practices context sensitive planning. Mr. Stallworth said that IDOT does practice CSS, but noted that not as regularly at Local Roads. There was additional discussion about the appropriate direction while the committee agreed to look at shifting the program and finding out more about the cost increases.

VI. North Shore Council of Mayors ARRA Program

Mr. Staron reported that two ARRA projects funded with leftover were let last Friday. He apologized for the confusion about the de-obligation of the ARRA funds and noted that some sponsors had to submit the paperwork twice or were never informed when the draft amendment was approved by IDOT.

VII. Congestion Mitigation and Air Quality (CMAQ) Program Update

Mr. Staron reported that the North Shore communities are making good progress on their CMAQ projects. He noted that a number of construction projects were let since the March meeting. Skokie let the Oakton St. Station, Morton Grove let the Dempster St. Project, and Glenview let the Greenwood/Glenview intersection project. He noted that status updates need to be submitted immediately. He informed Glenview that CMAP needs a letter to withdraw the Patriot Blvd. and Independence Ave. signalization project.

VIII. Other Business

Mr. Staron reported that the NWMC is updating its 2007 Bike Plan and map. He said that July will be spent examining potential E-W corridors.

IX. Next Meeting

Chair Schattner said that the next North Shore Technical Committee meeting is scheduled for September 15, 2010 at the Skokie Village Hall. Mr. Staron reported that the committee will see the shifted program at that meeting and approve the 2011 program.

X. Adjournment

Chair Schattner adjourned the committee.

Cost Increases:

Annually, a 3% cost increase is applied to all projects in the North Shore STP and on the multi-year B (MYB) list. This increase adds \$409,333 to the active North Shore STP.

Background: October 1, 2010 marks the beginning of Federal Fiscal Year (FFY) 2011. At the beginning of every FFY, the North Shore Council of Mayors Technical Committee reviews and edits its multi-year STP. In addition, at the beginning of each FFY, as a matter of policy, the North Shore Council approves an automatic three percent cost increase for STP projects. Last year, the Technical Committee chose to forego the three percent program cost increase due to the current economy and construction costs. Many of these changes must be approved by the North Shore Council of Mayors.

The requests increase the council's negative program balance by \$827,727 (after three percent increase) and conservatively decreases funding on the MYB List by \$1,194,883.
